#### 4. Appointment of Regional School District 13 Superintendent of Schools

Mr. Hicks moved the Regional School District 13 Board of Education appoint Dr. Kathryn Veronesi to the position of Superintendent of Schools for Regional School District 13 effective January 16, 2014 through June 30, 2016 at an initial base salary of \$155,000 (One Hundred Fifty Five Thousand Dollars) as documented in the employment contract dated October 16, 2013. Mrs. Adams seconded the motion.
