

**Regional School District 13 Board of Education  
Minutes of the Special Meeting of September 17, 2014**

The Regional District 13 Board of Education met in special session on Wednesday, September 17, 2014, at 7:30 p.m. in the music room at Korn Elementary School, 144 Pickett Lane, Durham, Connecticut.
