

## Regional School District 13 Board of Education Minutes of the Special Meeting of January 8, 2015

A special subcommittee of the Regional District 13 Board of Education met in special session on Thursday, January 8, 2015, at 12:00 p.m. in the Board Room at the Regional School District 13 Central Office, 135 Pickett Lane, Durham, Connecticut.

### **Call to Order**

Committee Chairman Norman Hicks called the meeting to order at 12:12 p.m. after it was determined that a quorum was present (minimum of three Board members).

### **Move to adjourn to Executive Session to discuss confidential student matters, as permitted by Conn. Gen. Statute § 1-200(6) and 1-210(b)(17) (student expulsion hearing).**

Mr. Renninghoff moved the Board of Education enter into executive to discuss a confidential student matter relating to a student in Regional School District 13 and to further review confidential student records pursuant to Conn. Gen. Statute § 1-200(6) and 1-210(b)(17) (student expulsion hearing). Mrs. Adams seconded the motion.

The Board of Education returned to regular session at 1:41 p.m.

### **Possible action regarding student expulsion**

Mrs. Adams moved that The Board of Education hereby moves to find that the student who is the subject of this proceeding did commit an expellable offense by possessing and distributing marijuana brownies during a school activity and by aiding in the procurement and distribution of marijuana brownies. Such conduct was violative of publicized policies of the Board seriously disruptive of the educational process and endangered other persons. Mr. Renninghoff seconded the motion.

### **Possible action regarding student expulsion**

Mrs. Adams moved that as a result of the student's conduct, he shall be expelled from Regional School District 13, including all school activities, curricular or otherwise, until the last day of the 2014-15 school year. During this period the student shall receive an alternative educational program to be provided by the school administration.

It is further moved that the student shall be eligible to re-enter school, at the discretion of the Superintendent, on April 6, 2015, if he meets the following conditions:

1. The student actively participates in the alternative education,
2. The student refrains from any further expellable offenses,

3. Within two weeks of April 6, 2015, the student must take and pass a drug test, at the Board's expense, and provides the results to the Superintendent prior to re-entry, and
4. The student serves 10 hours per week of community service to be approved by the Superintendent.

If the student is re-admitted early, the student shall continue to refrain from any further suspendable or expellable offenses. If the Superintendent in her discretion finds the student has engaged in such an offense, the student shall serve the balance of the expulsion period without a further hearing. If and only if the student meets all of the conditions stated above, the record of this expulsion shall be expunged on the last day of the 2014-15 school year.

Mr. Renninghoff seconded the motion.

Mr. Hicks thanked the Board for their time and careful consideration in this matter.
