#### **Board of Education**

#### **Regional School District 13**

The Regional School District 13 Board of Education met in special session on Monday, July 24, 2024 at 7:30 PM in the library at Coginchaug Regional High School.

Board members present: Mrs. Caramanello, Mrs. Dahlheimer, Dr. Darcy, Mr. DelVecchio (remotely), Mrs. Hurlbert (remotely), Mr. Mennone (remotely), Mr. Moore (remotely), Mrs. Petrella, and Mr. Roraback Board members absent: Mr. Stone Administration present: Dr. Schuch, Superintendent of Schools, and Mrs. Neubig, Director of Finance

Mrs. Dahlheimer called the special meeting to order at 8:42 PM.

#### **Pledge of Allegiance**

The Pledge of Allegiance was recited.

### **Approval of Agenda**

Dr. Darcy made a motion, seconded by Mr. DelVecchio, to approve the agenda, as presented.

### **Discussion on Public Hearing/District Meeting**

Mr. Mennone thanked the board for their comments tonight. He felt that the board has gone above and beyond to do what is financially correct for the district. He noted that they have done everything they possibly can to take the numbers into consideration, including number of students, cost per pupil and how to maximize the buildings. He felt people need to understand the financial impact that will happen if the district remains with five schools. He does understand that everyone is bothered by the transition plan, but emphasized that it is only a two-year period to get to the final goal. If this does not happen, Mr. Mennone felt that they will be setting the community up for failure with financial burden and schools that are falling apart. This issue has been belabored for two-and-a-half years and the board has done everything they can to answer every question.

Mrs. Dahlheimer added that the board has been careful and cognizant in listening and are trying hard to communicate better. She encouraged people to continue to reach out.

Mrs. Caramanello thanked Mrs. Dahlheimer for the amount of effort she has given to this. She wondered how anyone could still be misinformed. Mrs. Caramanello also thanked Mrs. Neubig for her hard work with the numbers. She hoped that the voters can see how important this vote is. Her daughter will be going into second grade and is not happy about leaving the school she loves, but her family continues to be positive. Mrs. Caramanello added that they cannot do much about programming at Strong and Coginchaug if they do not lower costs.

Mrs. Dahlheimer commented on the pathway programs at the high school and how STEAM has been a cornerstone and they want to continue to increase that. She agreed that that won't be able to happen if they have to concentrate on facilities. Mrs. Caramanello added that parents have to think further ahead.

Mr. Moore thanked Mrs. Hurlbert for her remote work on getting the next steps flyers completed.

## **BE IT RESOLVED:**

Subject to the approval of the Board of Education's attorney, the Board of Education authorizes the Superintendent to prepare and print explanatory materials regarding the proposed amendments to the Plan of Regionalization. The explanatory text and explanatory materials shall not advocate either the approval or disapproval of the referendum question above and shall be prepared in accordance with Section 9-369b of the Connecticut General Statutes.

Section 3. The following polling places shall be utilized for purposes of the referendum vote on the voting tabulators:
